A copy of the following documents must be included with this application prior to consideration for non-resident admission.

1. Student Academic Record, detailing final and quarter grades
2. Student Attendance Record, detailing absences and tardies
3. Student Disciplinary Record, detailing offenses
4. Copy of Gifted Plan, 504 Plan, and/or IEP if appropriate

Tuition for the 2017-2018 school year is \$1,000 per child (payable in one full installment or in four equal quarterly installments). Students who qualify for reduced lunch status have tuition of \$500 per year, per child. Students who qualify for free lunch status have tuition of \$200 per year, per child. Failure to pay the tuition in a timely manner will result in the student being denied enrollment and/or discontinuance as a student in the Middlesex County Public Schools. All applications for non-resident students are subject to School Board approval and will be reviewed based on the criteria listed below. Parents/Guardians will be notified of the School Board's action on all requests for admission.

### Eligibility Criteria for Non-Resident Students:

1. Student must be in good standing academically and behaviorally at the school previously attended.
2. Parent/guardian agrees to pay additional costs of services for students who participate in gifted education, special education/related services, Section 504 services, and/or regional programs.
3. Adequate space is available in the grade level and courses to which the student is applying.
